

## Services for the selection and provision, upon request, of analytical and/or generalized information for IPOs

The State Agency on Intellectual Property provides a range of services at the request of applicants, other than those related to the procedure of filing applications for the protection of intellectual property objects, of examination and registration thereof.

The activity of providing services by AGEPI shall be carried out at the request of applicants in accordance with the provisions of the [Instructions on providing services for the selection and provision, upon request, of analytical and/or generalized information for intellectual property objects](#) [1], approved by order of the Director General of AGEPI No. 98 of 21.08.2020. They establish the manner and conditions for the provision by AGEPI of services for the selection and provision, upon request, of analytical and/or generalized information for intellectual property objects, the rights and obligations of the persons involved in the activity of providing the services.

The fee for the requested services shall be paid in the AGEPI accounts, by any means available to the applicant of the service, based on the payment note issued by AGEPI, and the proof of payment of the fee shall be attached to the application.

If no proof of payment of the fee is presented within five working days of the filing of the application, the application shall not be examined and such fact shall be notified to the applicant of the service.

The term of examination of the applications for the provision of services is 15 working days from the date of registration of the application.
