Innovative technologies in the fields of engineering, energy efficiency, energy conservation, nuclear energy, environmental management, transportation and space systems, medicine, pharmacology, biotechnology were presented at the auction as 36 lots worth more than 1 billion rubles.

As part of the Second Auction of Intellectual Property "RUSINPRO-2013" will be put up the following objects of industrial property – inventions, utility models, industrial designs, trademarks, protected by patents of the CIS, Europe and the United States .

Auction Business program also includes an international conference "Investing in Innovation" and the exhibition-presentation of the scientific and technical developments and promising innovation projects.

The participants of the event will acquire the possibility to:

- Assess the prospects of development of the world economy;
- Learn about new effective ways for the commercialization of innovations;
- Demonstrate in action their own prototypes and models;
- Know the opinion of authoritative experts on the submitted technologies;
- Establish personal contact with business angels, investors of the innovative companies, public authorities and representatives of large business in Europe and the CIS;
- Get the maximum income from the sale of the lot.
